I am Arta, a second-year law student at the University of Exeter. I am a state-educated, firstgeneration student from London. My motivation for pursuing a career in law stemmed from undertaking legal work experience at a commercial law firm during my A-levels.

During my first year studying law, my laptop would randomly stop working, and this would prolong the time I spent on assessments and exams. Money was tight, so purchasing a new laptop was not possible. However, I knew that the requirement of a new laptop would aid me in my law degree.

Receiving a laptop from the AS Foundation has allowed me to write applications to law firms for their vacation schemes. I can also spend less time on assessments and exams as this laptop doesn't crash. This has freed up my time and allowed me to worry less about my laptop not working and needing to save my document every five minutes.

The AS Foundation is breaking financial barriers that students such as myself face. It is fantastic that I have been supported by the AS Foundation and I urge students in a similar position to apply for financial support.
