I come from a single-parent, working-class background. I am also the first person to attend university in my family and I was estranged in 2021.

I'm in my second year at Warwick University. I currently work as a Legal Advisor, and I have been fast-tracked onto a vacation scheme. The AS Foundation has provided me business clothing and travel tickets for the vacation scheme.

I was granted a laptop by the AS Foundation last June and I'm still using it today. It has allowed me to complete work experience opportunities, attend networking sessions, apply for jobs/vacation schemes, and explore further opportunities with ease. So many doors have been opened for me after I was provided with the laptop, and I am now able to confidently pursue my career in law. I would recommend the AS Foundation to anyone from a low income background. I would have otherwise really struggled. A laptop is such a big thing for university, and I couldn't afford one. I am very grateful.

I am currently working in a conveyancy firm, but the big dream for me is to work with different LEDCs to help with issues such as immigration. I want to start my LPC soon but will have to save money to self fund the course.

I graduated from the University of Law in November 2021, and the laptop granted by the AS Foundation was really helpful during my undergraduate degree. When COVID hit, it helped me to do my coursework at home and I would have really struggled to get any work done without it.

I would definitely advise other aspiring solicitors to apply for a grant. When I applied, I was on my way home from a night shift and was tired from juggling work and university. I wasn't in the financial situation to get a laptop and I don't know how I would have been able to do anything without the help of the AS Foundation.





The AS Foundation has been really helpful. My previous laptop was heavy and didn't work very well, so I was struggling. I have an autoimmune condition which makes it hard to type, but the AS Foundation granted me a laptop that can be used as a tablet, which makes it much easier as it has a touch screen. It is also easier to transport to university with me, and I have completed some virtual internships using the laptop.

I want to be a real estate lawyer: I have done many varied internships and real estate is most interesting to me. I did an internship in construction and have done lots of internships in law, so I feel like this combines the two.

Thanks to the AS Foundation, I was also granted a part funded scholarship to BPP, which will help me progress in my journey to becoming a solicitor. I wouldn't have been able to do a Law Conversion course without the scholarship – it just wouldn't have been an option for me. Working and studying at the same time was difficult because of my condition and I found that very stressful.

I found the AS Foundation easy to apply for and was pleasantly surprised to be granted twice. The scholarships are particularly useful as so many students have no idea how they are going to get that kind of money.



I really appreciate everything the AS Foundation has done for me in my journey towards becoming a solicitor. After applying for a laptop, the AS Foundation bought me one to help with my studying. This has allowed me to hit the ground running in my degree and take proper, detailed notes during lectures and seminars.

I applied to A&L Goodbody for their summer intern programme and was successful. The AS Foundation provided me with business clothing, so I was able to attend the intern programme, looking and feeling equal in the office. Ahead of that I was offered some coaching from one of the AS Foundation's charity partners who specialise in helping individuals be the best version of themselves at crucial moments in their lives.
